

The Delaware, Ohio Grand Circuit meet (September 20-24, 2020), including the Little Brown Jug (Thursday, September 24), will be conducted under local and state guidelines and the Ohio State Racing Commission's *Safe Return to Racing*.

Race Events:

The Buckeye Stallion Series (Two Year Old Filly Trot) has been moved from Wednesday to Tuesday.

- The Signature Series Trot Final (Monday), the Hall of Fame Trot Final (Thursday) and the Signature Series Pace Final (Thursday) have been cancelled.

Horseman Access:

- Horsemen that are experiencing any of the symptoms outlined on the attached "COVID-19 Symptoms" flyer are to remain home or otherwise isolate themselves and seek medical care as soon as possible.
- If any horsemen become ill while on the grounds, they should isolate themselves in their camper or vehicle or otherwise not come in contact with anyone. They should also inform Tom Wright, Race Secretary by calling 740-362-3851.
- Horsemen will only be allowed to enter the U.S. Route 23 Gate.
- Only drivers, trainers, grooms or owners will be admitted.
- Limited to horses racing that day or those stabled at the fairgrounds.
- A valid Ohio State Racing Commission (OSRC) license must be presented at the time of entry.
- Each OSRC license will be inspected for description type.
- Delaware County Fair personnel will verify participation and may deny entry.
- Unlicensed horsemen must go directly to the OSRC licensing office in the Log Cabin.
- The 23 gate will be the only gate left open 24 hours a day and will be staffed the entire time.

Owners:

- Owners that are experiencing any of the symptoms outlined on the attached "COVID-19 Symptoms" flyer are to remain home or otherwise isolate themselves and seek medical care as soon as possible.
- Licensed owners and one guest will be permitted to attend on the day their horse is racing.
- A valid Ohio State Racing Commission (OSRC) license must be presented at the time of entry.
- Each OSRC license will be inspected for description type.
- Delaware County Fair personnel will verify participation and may deny entry.
- Unlicensed owners must go directly to the OSRC licensing office in the Log Cabin.
- Owners and their guest will be permitted in the grandstand area and will be required to socially distance themselves (6' or more) from others.
- Owners and their guest will be required to wear a suitable mask or face covering while walking around the grounds and grandstand.

Spectators:

- No spectators will be admitted.
- A list of simulcast outlets will be made available as they are confirmed.
- Full card past performance programs will be available at LittleBrownJug.com.

COVID Prevention:

- All horsemen, owners, staff and volunteers that are experiencing any of the symptoms outlined on the attached "COVID-19 Symptoms" flyer are to remain home or otherwise isolate themselves and seek medical care as soon as possible.
- Confirmed or suspected cases should isolate to their camper, vehicle or go home.

- Any horsemen, owners, stall and volunteers that are waiting on results of a Covid test should not attend.
- All horsemen and personnel will be required to wear a suitable mask or face covering while on the grounds, except for drivers seated behind a horse or when a distance of more than 6 foot from another person can be maintained.
- As much as possible, social distancing (6' or more) must be observed. No congregating in any backside area.
- Hand sanitizing stations will be provided and horsemen are encouraged to use them frequently.
- Restrooms and two portable toilets will be cleaned and sanitized on an hourly basis and will be closed intermittently for 10-15 minutes for a more thorough cleaning.
- Employees and volunteers will be educated during either a pre-fair or morning race-day meeting on social distancing guidelines, handwashing and other safety measures.
 - o The Race Secretary and Sponsorship Manager will be supervisors on site for volunteers to report issues and to correct actions to ensure safety guidelines.

Log Cabin (Race Office):

- Horseman shall enter the east door and will exit the south door.
- Social distancing (6' or more) must be observed.
- Electronic, on-line entries are required and should be submitted through the USTA's system prior to arrival at the fair.
- Racing office staff will monitor the number of individuals in the racing office area and shall limit the number of individuals allowed in the racing office area if it becomes impossible to follow safe social distancing practices.
- When possible all starting fee's should be overnighted to:

- Suitable mask or face covering must be worn at all times while in the race office by everyone, including employees, volunteers and horsemen.

Paddock:

- We will use a three race paddock. Please arrive at the appropriate time.
- Paddock access will be limited to officials, the trainer, groom, warm up personnel and horse.
- All paddock entrants must sign in before entering into the paddock area. Two people per horse will be allowed in the paddock.

Win Circle:

- Finish and win circle photos will be taken.
- Social distancing (6' or more) must be observed.
- Horsemen and owners are required to wear a suitable mask or face covering.
- Only horsemen and owners directly affiliated with the winner will be permitted in the win circle.

Procedures for onsite personnel and horses:

- Antibacterial liquid soap will be kept stocked in restrooms, portable restrooms and bath houses.
- Personnel are urged to make frequent use of hand sanitizer stations and soap in the restrooms.
- Sharing of barn/horse equipment shall be minimized. If used by multiple horsemen, equipment shall be sanitized by horsemen between each use.

- Appropriate signage will be displayed in key areas to encourage a safe environment.

Ship-Ins:

- Horses that are shipping in shall:
 - o Visit the “Stall Man” to receive their barn/stall assignment.
 - o Proceed to the assigned stall in receiving barns (#25, #26, #28 or ‘Hoop’ Barn)
 - o Not ship into a permanent onsite stall under any circumstances.
 - o Depart the property the same day – no exceptions.
 - o Out of state ship-ins will be handled on a one-off basis. Every effort will be made to isolate those out of state horses to a particular barn.
 - o Horsemen are responsible for daily cleaning of all frequently touched surfaces.

Camping:

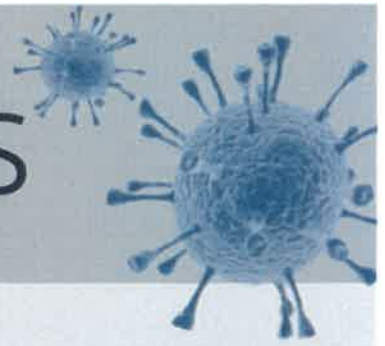
- Limited camping site permits will be available for participating horsemen, owners and officials only.
- Permits must be purchased in advance by calling (740) 362-3851.
- Social distancing (6’ or more) must be observed.
- We will strictly enforce the State of Ohio’s *Responsible RestartOhio* Camping and Campground requirements, including the 10:00 PM curfew.

Food and Drink:

- Two concession stands will be open between Barns 36 and 38.
- Concessionaires are required to follow the Responsible RestartOhio for Restaurants, Bars and Banquet and Catering Facilities/Services.
- Bottled water will be available in the paddock for participating horsemen.

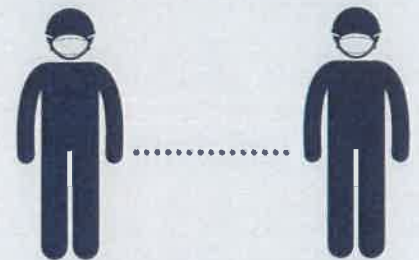
