FIGURE 8 FULL SIZE AND COMPACT VEHICLE RULES AND REGULATIONS

GENERAL:

- Entry fee is \$20
- Only the **DRIVER** will receive gate admission and pit pass
- All entrants must be 18 years or older. The Delaware County Fair Board (Delaware County Agricultural Society), Committee Members, EMS, Law Enforcement, Fire Department, Delaware County Motorsports Inspectors and Officials, and any associated members WILL NOT be held responsible for any bodily injuries or damage of cars, participants, spectators, mechanics, or car owners.
- Any protest must be requested at least 10 minutes before the first vehicle of the scheduled heat rolls onto the track. A \$100 fee and the specific area of protest must be produced before the vehicle is re-inspected. If the protest is upheld, that particular vehicle will be forced to correct what is found to be illegal or will not be allowed to participate.
- All winning trucks may be subject to re-inspection after heat or feature to confirm that the truck is legal. If the truck is not legal, the participant will forfeit their entry fee and prize money. The Delaware County motorsports official's decisions are FINAL. All participants must wear a helmet, eye protection, long sleeve shirt, pants, and closed toe shoes. All vehicles must have a seat belt and working brakes before inspection.

CLASSES:

- **COMPACT**
 - o A compact car is a passenger car with a wheelbase of 109" or less. ALL FIGURE 8 COMPACT CARS MUST BE FRONT WHEEL DRIVE AND 4, 6 OR 8 CYLINDER.
- **SUV CLASS**
- **COMPACT TRUCK**
 - o A compact truck is any truck model less than ½ ton with a 4 or 6-cylinder engine
- **FULL SIZE TRUCK**
 - o A full-size truck is any truck model rated ½ ton or greater with a 6 or 8-cylinder engine.
 - o A truck model rated less than ½ ton of less with an 8-cylinder engine will be considered a FULL-SIZE truck
- **IT WILL BE UP TO THE DISCRETION OF THE MEMBERS OF THE DELAWARE COUNTY FAIR BOARD ON THE MOTORSPORTS COMMITTEE TO CHANGE A VEHICLE TO A DIFFERENT CLASS*****

RULES AND REGULATIONS:

- Each heat will be 10 laps
- The top 3 vehicles from each heat will return for the feature event for that class
- The feature event for each class will be 20 laps

- 4x4 or AWD vehicles are **NOT** permitted. If the vehicle is 4x4 or AWD, the **FRONT** drive shaft must be removed prior to inspection. All vehicles must be rear wheel drive only.

- Windshields are permitted. **All other glass including any side windows, back glass, mirrors, and lights MUST be removed prior to inspection. ALL GLASS MUST BE REMOVED PRIOR TO ENTERING THE FAIR GROUNDS, NO EXCEPTIONS.**
- The cabs and beds of participating vehicles must be swept clean of any and all debris prior to inspection for safety reasons
- The doors must be wired, chained, or welded shut for safety reasons. If any door becomes open or detached during the event, the event will be stopped and that vehicle will be removed from the competition and disqualified
- Cages in the cab of a vehicle are allowed. A roll bar is permitted as well, if any of the cage components or roll over bar become detached during the event, that vehicle will be disqualified and removed from the competition areas for safety reasons
- Fabricated front bumpers are permitted but must **NOT** be wider than the factory dimensions of the front of the vehicle
- All tires must be D.O.T. approved. No skid loader or tractor lug tires for safety reasons
- All metal protective shields for the radiator are permitted
- It is recommended to replace the stock gas tank with a metal fuel cell or boat tank in the cab of the vehicle or in the center of the bed directly behind the cab or the vehicle. If replacing the stock tank, you may build a protective cage around the fuel cell. The fuel cell must be securely fastened and covered prior to inspection.
- It is recommended to relocate the battery to the driver's compartment of the vehicle. The battery must be securely fastened and covered prior to inspection.
